

**2018 Camp Fire Rebuild Incentive Program Application (V4)**

**One of the following grants may apply to your re-building permit:**

**NORTH VALLEY COMMUNITY FOUNDATION (NVCF)**

\$500,000 – Thru February 28, 2021

**Grant Eligibility**

- Survivors whose home was completely destroyed
- 50% Max, up to \$3500
- Owners only eligible for one grant
- Property owners at the time of the Camp Fire, where dwelling was destroyed.
- May rebuild anywhere within the burned communities.

**GOLDEN STATE FINANCIAL AUTHORITY (GSFA)**

\$250,000 – 2 yrs from receipt of Grant funds

**Grant Eligibility**

- Property owners at the time of the Camp Fire, where dwelling was destroyed.
- Non-Veterans – 50% Max, up to \$3500, veterans with qualifying DD214 may receive additional funds
- Owners only eligible for one grant
- Building permit required to rebuild
- Rebuilding a comparable (or smaller) replacement residence within an unincorporated community of Butte County substantially affected by the Camp Fire..

**CHECK HERE IF YOU ARE A VETERAN AND WANT TO APPLY FOR GRANT FUNDS WITH VETERAN STATUS** . Must also supply a copy of your DD214 form which states the character of service as “Honorable”. Other phrasing which indicates other types of discharge, i.e. “Under Honorable Conditions” are not qualifying for purposes of the grant. Your VA office can assist you in obtaining a copy of a DD214 form.
