- 4.01 ML2/ML3 Update – Meeting at Lassen National Forest Almanor Ranger District Office: Peggy Moak and Thad Walker attended. Attendees were encouraged to comment for any critical misses on the plan as the comment period had been extended.
- 4.02 Discussion of the “Southside” Roads (Mike Rich?) 24N04 and KimsheW Point area roads – Nick Repanich – Moved to a future meeting.
- 4.03 5:30 Timed Item: Air Curtain Burner Webinar – Mike Schmidt- Mike gave an overview of the use of air curtain burners and their applications. Several examples were shown, and the committee asked questions regarding the cost of the burners and the regulations and permits needed to operate.

Butte County and the Town of Paradise have both hired arborists following the Camp Fire. PG&E has begun work removing trees from their right-of-ways.

- Butte County Sheriff’s Search & Rescue- \$34,330/\$22,891 match= 2 snowmobiles & related equipment

The Butte County Federal/State Land Use Coordinating Committee (LUCC) supports this grant application. The LUCC is a Board appointed (Brown Act) committee representing Butte County citizens’ interests in the areas of recreation, forest management, tourism/economic development and environment/watershed, working closely with the Plumas and Lassen National Forests and other public land managers. These comments were developed at a public meeting with input from the public. The LUCC is strongly supportive of this grant application and the vital need for the purchase of the snowmobiles and snowmobile training to better enable safe access to snow covered areas in the local OHV areas for the Butte County Search and Rescue units.

- Tehama County RCD- \$112,230/\$49,478 match= Demolishing and replacing Fischer Campground toilet

RE: *Lassen National Forest (LNF) Motor Vehicle Use Map (MVUM) Update Project*

The Butte County Federal/State Land Use Coordinating Committee (Coordinating Committee) is writing in support of the proposed revisions to the LNF MVUM. The Butte County Board of Supervisors supports this proposal, pursuant to their letter of March 26, 2019, and in light of their involvement as one of the five counties advocating for revisions providing authorization for OHV travel on roads historically utilized for that purpose, prior to implementation of the 2010 LNF MVUM.

The Committee is charged with facilitating public involvement and feedback on forest management and recreational enjoyment of public lands in and around Butte County through its own public meetings and coordinating those of the Butte County Forest Advisory Committee (FAC), which meets regularly on the 4th Monday of each month. The LNF Almanor District Ranger is routinely asked to participate and present at the monthly FAC meetings, as is the Plumas National Forest Feather River District Ranger. As Board appointed committees, both the Coordinating Committee and the FAC have been intent upon forging strong collaborative relationships with public land managers, fostering open communication and planning opportunities.

We'd like to thank you for the opportunity to participate in the public meeting held on April 4, 2019, in Chester where a healthy discussion was held regarding the engineering study and basis for the recommended action. While we believe there is more work to be done, it is gratifying to see progress made in restoring OHV access on dirt roads historically used for that purpose by our citizens and those of the other surrounding counties.

One of the points that came to our attention during the meeting was the fact that not all of the roads submitted in 2012-2013 for consideration for a return to historic OHV use were included in the study. This is understandable given the capacity issues of the LNF and direction from the Regional Office; however, we respectfully request that those roads listed on the original 2012-2013 submission from Butte County, and other counties, which were not included on the engineering study, continue to be earmarked for future consideration for a return to authorized OHV use.

At the most recent public meetings held by the Coordinating Committee and the FAC, public input has re-emphasized the importance of the LNF's future consideration of Forest Service Road 27N06, which connects Humboldt Road to Highway 32 and crosses numerous OHV routes that would enable enhanced OHV loop travel opportunities. This is especially important as the Jonesville area, the Humboldt Road origination point, is a major recreational hub for Butte County's OHV enthusiasts.

Mixed use on the 27N06 would provide access to the Rattlesnake Creek OHV loop, and would also complement the plans being made for a collaborative OHV Grant (LNF, Butte County, Hillsliders and the Butte County RCD) to improve the parking area at the Jonesville Snowmobile Park for both winter use and an OHV staging area. We realize this cannot be considered as part of the current action, as it was not part of the study area; however, the Coordinating Committee encourages the LNF not to lose sight of the County's original (2012-2012) request to honor stakeholder feedback and strongly consider this route as Mixed Use in a future revision to the MVUM.

Russell Nickerson, Almanor District Ranger, disclosed that the other outstanding route submitted by Butte County for consideration, Forest Service Road 26N02, was not recommended for OHV mixed use or downgrade to an ML2 road as a result of internal discussion at the Almanor District level, primarily due to concerns about the crossing of the Pacific Crest Trail. While we understand the District's concerns, we find this decision regrettable as there are numerous OHV roads beginning and ending on, and crossing, the 26N02. The Coordinating Committee is not asking for a change to the proposed action at this time; however, requests that consideration be given to a compromise solution at a future date.

Thank you for your time and consideration. Once again, the Coordinating Committee, and the public we serve, are gratified to see progress on the issue of enhanced OHV access and enjoyment in the Lassen National Forest and look forward to our continued Coordination and collaboration.
