Planning application fees are charged at the time a complete application is filed with the department and include costs and staff time incurred by other County departments for their review. Fees are separated into two categories: Retainer Fee and Flat Fee. Applications with a Retainer Fee are intended to recover the costs of staff time for processing the application and can vary widely depending on the complexity of the application. If the initial retainer amount becomes depleted, the applicant must replenish the retainer to allow staff to continue processing the application. All unused retainer funds will be refunded to the applicant upon completion of the application.

(EH) Environmental Health Division Review Fee - Prior to application submittal, applicants must obtain a Pre-Application Review Letter from the Environmental Health Division. Fees will be partially collected by Environmental Health with the remaining amount to be collected by the Planning Division when the complete application is filed.

(1) - The contract hourly rate for Planning Staff time is \$176 per hour. An additional 4.5% General Plan Maintenance Fee and 2% Technology Investment Fee is assessed to the hourly rate for a total of \$187.44.

(2) Agricultural Commissioner Review Fee (AG) - A preliminary determination will be made by Planning Division Staff whether the application will require a review by the Agricultural Commissioner. In general, applications located on or adjacent to an Agriculture-zoned property will be referred to the Commissioner. The AG review fee is as follows: Building Permit Clearance \$204 (Flat); Tentative Maps \$328 (Flat); Unusual Circumstance Review and Other Planning Applications \$272 (Flat).

(3) - CEQA Document Filing Fees are collected by the California Department of Fish and Wildlife at the time a Notice of Determination is filed with the County Clerks Office, within 5 days of approval. In most cases, a Negative Declaration will be prepared for your application if the project is deemed not to be exempt. However, an alternative filing fee is collected if an Environmental Impact Report is prepared for your application. These fees are collected to defray the costs of managing and protecting California's fish and wildlife resources including, but not limited to, consulting with other public agencies, reviewing environmental documents, recommending mitigation measures, and developing monitoring programs.

(4) - Most applications will require compliance with the California Environmental Quality Act (CEQA) through the preparation of either a Negative Declaration, EIR, or Exemption. If one of these CEQA documents are adopted by the County, either a Notice of Determination or Notice of Exemption will be filed with the County Clerks Office, which includes a \$50 processing fee.

Northeast Information Center (NEIC) Review - A \$75 fee may be assessed if your application requires a records search of potential archaeological resources on the project site to meet the requirements of the California Environmental Quality Act (CEQA). Payment of this fee requires a separate check made payable to NEIC.

Re-Billing/Invoicing - Retainer Fee applications may require additional funds if the original fee amount becomes depleted. An invoice requesting replenishment of the account will be sent to the applicant when the retainer is drawn down to 25% of the original amount, prior to a scheduled hearing, or upon closing of the application. Any unused portion of the retainer will be refunded.
