*Food and Agriculture Code Section 861 et seq., Food and Agriculture Code Section 885 et seq.,  
Butte County Code Section 1-7., Butte County Ordinance No. 4055 et seq.*

*A failure to provide proof of ownership of certain agricultural commodities is a misdemeanor and can result in forfeiture of the commodities. Agricultural commodity means any food product of a tree, vine or plant. Proof of ownership means evidence that you are the grower of the commodity. All persons found to be in violation of this article shall be guilty of misdemeanor which will be punishable as provided in section 1-7 of the code. Pursuant to Food and Ag Code Section 885 the commissioner may levy a civil penalty in lieu of civil prosecution.*
