I. CALL TO ORDER

- a. Steven Bordin, Chief Probation Officer called the regular meeting of the Community Corrections Partnership (CCP) to order at 9:02 a.m., on July 19, 2017, at the Chico Probation office located at 1370 Ridgewood Drive #22, Chico, California 95973.

II. SUB-GROUP COMMITTEE REPORTS/UPDATES

BUTTE COUNTY PROBATION

--- Dwayne Martin, Program Manager, reports out on data for FY 16/17 regarding Post-Release Community Supervision (PCS) and Mandatory Supervision (MS) and Current Point in Time Population. Handout provided.

Amy Asher, Probation Officer III, gave a report on the May Probation and Community (PAC) meeting stating there were 21 providers and 38 offenders in attendance. In June there were 26 providers and 57 offenders in attendance. Ms. Asher also reported they have started the Job-Readiness classes with 22 persons involved.

Mike Rogers, Supervisor Probation Officer, gave reports on the Male Community Re-entry Program (MCRP) and the Transitional Age Youth (TAY) program. MCRP is at capacity (20). 29 enrollments, 22 completions, 18 identification cards 5 Social Security cards, 19 birth certificates and all 29 have received Medi-Cal. Overall, 117 different programs have been completed. 186 hours of community service have been completed. Post-program, 22 participants have all been stable with employment, housing and SSI. 6 successful discharged from PCS via MCRP. Restitution collected from participants to date is at \$6,500. 1 participant paid off all his fines and fees which brings it up to \$9,500 in restitution for the year.

With respect to the TAY program, there are currently 9 with 2 more enrolling as of today. Programs completed 11 programs total and have been able to secure employment for 2 of the participants. Completed 60 hours of community service. Two people have completed the program and are back out in the community and have stable housing. 1 employed, 1 in school at Butte College.

BUTTE COUNTY SHERIFF'S OFFICE

--- Lt. Hovey gave a report on their Alternative Custody Program (ACS) population, currently 115; SWAP is 121. There are currently 18 ACS individuals on work crews such as fire safe, road repair and the municipal park areas. Lt. Hovey also reported on the Second Chance K-9 Unit, working with individuals and veterans groups for Tehama, Shasta, Yuba and Sutter counties. The jail's population is currently 591 with 40 in programming. Recently, they just started a Catalyst program within the jail; approximately 20 individuals.

BUTTE COUNTY BEHAVIORAL HEALTH

--- Dorian Kittrell, Director, provided a handout to the CCP members. In summary Mr. Kittrell reports there are 22 individuals enrolled as of June 17, 2017. 470 services provided for FY 16/17. Of special note, Mr. Kittrell points out that there are not very many individuals who are in crisis within the AB109 program.

DISTRICT ATTORNEY'S OFFICE

BUTTE COUNTY DEPARTMENT OF EMPLOYMENT AND SOCIAL SERVICES

--- Shelby Boston, Director, provided a handout to the CCP members on DESS's current data. Ms. Boston reports that there has been an upward trend of active or pending cases. Active employment currently stands at 221; with 1 General Assistance (GA) case granted.

BUTTE COUNTY OFFICE OF EDUCATION

--- Debbie Morris reported to the CCP members present that on July 10 started a summer program from 8-12, M-Th. The full program will begin on August 16, in sync with the Comeback Butte Charter School, which will be the educational entity with the JAG grant (YouthBuild). Also, the Alliance for Work Force Development (AFWFD) will cover half the salary of the case manager that is coming on board this summer; the focus will be vocational.
