

SOLID WASTE WEBSITE- FAQs

- 1) Where can I take used paint, batteries (of all kinds), fluorescent light tubes, pesticides or other types of household hazardous waste?

Your old cans of paint, batteries (all kinds), fluorescent light tubes, TVs, can be taken to your local household hazardous waste facility. Please follow the link to Recycle Butte to find the household hazardous waste facility near you:

- 2) Where can I take my electronic waste (E-waste), such as TVs, computer monitors or other electronic devices with cathode ray tubes for recycling?

- 3) How do I tell if an item I want to discard is medical waste, and how/ where do I dispose of it?

If the item you are discarding does not meet the definition of medical waste, you can dispose of it as normal garbage/ solid waste.

If the item you are discarding does meet the definition of medical waste, it must be stored separately (from your normal garbage) and treated/ autoclaved before it can be disposed of. Businesses which generate medical waste are classified by the amount of medical waste they produce see the [MEDICAL WASTE INFORMATION BULLETIN AND DISPOSAL GUIDE](#). - 4) How do I dispose of old prescription drugs/ medications?

- 6) Who do I call about a trash/ garbage complaint?
You can call Butte County Environmental Health to report a garbage/ trash complaint at 530) 538-7281.
- 7) Where can I recycle my used items if I don't want to place the items in my recycling bin?

- 8) How do I properly dispose of my used car tires? What if I have a lot of car tires to dispose of?
Vehicle tires can be properly disposed of at Neal Road RWF. Some companies that sell tires will also take back the used tires.
Neal Road Recycling and Waste Facility, (also Northern Recycling) periodically holds a Tire Amnesty Day, please contact Neal Road RWF to obtain additional information at 530) 538-7681. If you need to dispose of more than 9 tires, you will need to obtain an application for a one day exemption to haul waste tires.

- 9) Who would I call to get garbage service started?
Depending on where you live, there are 3 garbage companies in Butte County.
If you live in the county:
The county was recently divided into franchises, so the garbage company servicing your area will depend on your geographical location. You can use this website to determine which company to contact: <http://www.buttecounty.net/recyclebutte/CollectionAreas.aspx>
Garbage services in the cities has not been franchised at this time.
- 10) How do I properly dispose of old furniture/ bulky items?
You can take your old furniture or bulky items to Neal Road RWF or, you can call your garbage company to make arrangements for pick-up of your bulky items.

- 12) Can I bury or burn my own trash?
No. Trash cannot be burned or buried on your own property.

13) Where can I take a load of brush/ tree trimmings/ yard waste? Where can I get compost to use in my garden/ yard?

You may have green waste pick-up as part of your garbage service. You can also take loads of green waste (including brush, tree trimmings, grass clippings, etc) to one of the facilities that make compost. You can also purchase compost at these locations for use in your garden or yard. These facilities can be found using the [GREEN WASTE/ COMPOSTING](#) website link.
