EVICTIONS \$145, LOI, Original WRIT + 2 copies

EVICTIONS – Reposting [if we still have WRIT] \$80 + LOI stating Repost request

EVICTIONS – Reposting [WRIT already sent back to court] \$145, LOI, must have new WRIT + 2 copies

EVICTIONS – Court Issued Stays No fee + letter notifying us of release and new lockout date

EVICTIONS – Attorney/Plaintiff Stays \$80 fee + letter notifying new lockout date

Automobile Levy \$1500, LOI, Original WRIT+2 copies (more \$ if Store & Sell)

Bank Levy \$40 per Bank, LOI, Original WRIT+2 copies

Employee Withholding Order \$35, Application for EWO, Original WRIT [\$35/Employer on 1 employee]

Going Business Levy:

 Keeper – 8 hour \$240 (\$100+\$140) LOI "Keeper Levy Instructions", Original WRIT + 2 copies

 Keeper – 12 hours \$400 (\$100+\$300) LOI "Keeper Levy Instructions", Original WRIT + 2 copies

 Till Tap Levy \$100, LOI, Original WRIT+ 2 copies

Monies Due/Third Party Levy \$40, LOI, Original WRIT+ 2 copies
