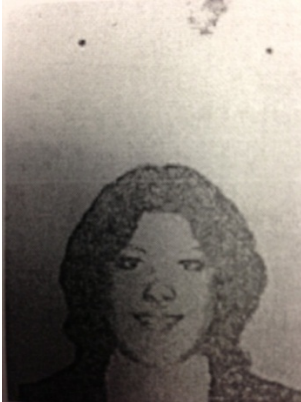

Although Woolen was not suspected of involvement in the disappearance of Rhonda Yocom, it is believed that he may be responsible for the disappearance of Paget Barr, a subsequent girlfriend (Refer to missing person case on Paget Barr). Rhonda Yocom was initially described as being from Asian decent in the original missing persons report, she is actually Pilipino. Rhonda has never been heard from again and it is believed that she is the victim of a homicide.
