APPLICATION TO CONDUCT BINGO GAMES

Eligibility Requirements: Butte County Code [Section 15-40 - Organizations eligible for county license to conduct bingo games](#). Organizations exempted from the payment of the bank and corporation tax by [sections 23701a, 23701b, 23701d, 23701e, 23701f, 23701g and 23701l of the Revenue and Taxation Code](#) and mobile home park associations and senior citizens' organizations are eligible to apply to the county for a license to conduct bingo games in the county under the provisions of section [326.5 of the Penal Code](#) and the provisions of this article.

Directions:

- Before you apply, review [Butte County Code – Chapter 15, Article II](#) to determine if your organization is eligible and can comply with the requirements. Applicant will need to provide proof of qualification.
- By signing below, the applicant agrees to abide by [Penal Code Section 326.5, Revenue & Taxation Code sections 23701a, 23701b, 23701d, 23701e, 23701f, 23701g and 23701l](#), and [Butte County Code – Chapter 15, Article II](#).
- Complete the first page of this form, attach supporting documentation, and obtain approval from each Butte County department listed on page 2.
- When all signatures have been obtained, bring the completed form, supporting documentation and the \$50.00 Bingo License fee to the [Butte County Treasurer-Tax Collector's Department – Central Collections Division, 25 County Center Dr. Suite# 125 Oroville, CA 95965](#).
