What is “eComment”?

eComment is an online tool for community members to provide before-hand and/or real-time written feedback electronically on Board Meeting agenda items.

All eComments are forwarded instantaneously directly to each Board Member and is incorporated in the public record and published online.

eComment Deadline:

Submissions will be accepted through the close of the Board Meeting.

What is “Register to Speak”?


Register to Speak is a way for community members to register online to speak virtually from a remote location on agenda items during Board Meetings.


After registering, you’ll be emailed the meeting link and call-in information to use when tuning in on Board Meeting day!
