602 (h) P.C. {FENCES GATES AND SIGNS}

WILLFUL OPENING, TEARING DOWN, OR OTHERWISE DESTROYING ANY FENCE.....OR OPENING ANY GATE, BAR, OR FENCES OR ANOTHER AND WILLFULLY LEAVING IT OPEN...

602 (k) P.C. {POSTED LANDS}

ENTERING ANY LANDS..... ENCLOSED BY FENCE WHERE SIGNS FORBIDDING TRESPASS ARE DISPLAYED.....ALONG ALL EXTERIOR BOUNDARIES.....AND: **602 (k)(2) P.C.** REFUSING OR FAILING TO LEAVE THE LANDS IMMEDIATELY UPON BEING REQUESTED BY THE OWNER, OWNERS AGENT OR PERSON IN LAWFUL POSSESSION.....

602 (l) P.C. {OCCUPATION}

ENTERING AND OCCUPYING REAL PROPERTY OR STRUCTURES OF ANY KIND WITHOUT THE CONSENT OF THE OWNER, OWNERS AGENT, OR PERSON IN LAWFUL POSSESSION.

602 (n) P.C. {REFUSAL TO LEAVE PRIVATE PROPERTY}

REFUSING OR FAILING TO LEAVE LAND, OR S TRUCTURES NOT OPEN TO THE GENERAL PUBLIC, UPON THE REQUEST TO LEAVE BY: **602 (n)(1) P.C.** A POLICE OFFICER AT THE REQUEST OF, PERSON IN LAWFUL POSSESSION..... **602 (n)(2) P.C.** THE PERSON IN LAWFUL POSSESSION, A SINGLE REQUEST FOR A PEACE OFFICERS ASSISTANCE MAY BE MADE TO COVER A LIMITED PERIOD OF TIME NOT TO EXCEED 30 DAYS AND IDENTIFIED BY SPECIFIC DATES. 602. 1 (a) P.C. {OBSTRUCTING OR INTIMIDATING BUSINESS OPERATORS}

ANY PERSON WHO INTENTIONALLY INTERFERES WITH ANY LAWFUL BUSINESS CARRIED ON BY THE OWNER OR AGENT OF A BUSINESS OPEN TO THE PUBLIC BY OBSTRUCTING OR INTIMIDATING THOSE ATTEMPTING TO CARRY ON BUSINESS OR THEIR CUSTOMERS, AND WHO REFUSES TO LEAVE BY THE OWNER OR AGENT OR BY A PEACE OFFICER ACTING AT THE REQUEST OF THE OWNER OR AGENT...*(HIS INCLUDES SUBJECTS WHO BLOCK THE ENTRANCES TO STORES)*

602.5 P.C. {UNAUTHORIZED ENTRY OF PROPERTY}

EVERY PERSON OTHER THAN A PUBLIC OFFICER OR EMPLOYEE WHO ENTERS OR REMAINS IN ANY NONCOMMERCIAL DWELLING HOUSE, APARTMENT, OR OTHER SUCH PLACE WITHOUT CONSENT...

DISORDERLY CONDUCT

647 (f) P.C. {DRUNK IN PUBLIC}

647 (h) P.C. {PROWLING}

ANY PE RSON WHO LOITERS, PROWL, OR WANDERS UPON THE PRIVATE PROPERTY OF ANOTHER AT ANY TIME, WITHOUT VISIBLE OR LAWFUL BUSINESS WITH THE OWNER OR OCCUPANT..."LOITER" MEANS TO DELAY OR LINGER WITHOUT A LAWFUL PURPOSE FOR BEING ON THE PROPERTY AND FOR PURPOSE OF COMMITTING A CRIME AS OPPORTUNITY MAY BE DISCOVERED.

647 (i) P.C. {LODGING}

ANY PERSON WHO LODGES IN ANY BUILDING STRUCTURE, VEHICLE OR PLACE, WHETHER PUBLIC OR PRIVATE, WITHOUT THE PERMISSION OF THE OWNER OR PERSON ENTITLED TO THE POSSESSION OR CONTROL...
