**OBSERVATIONS AND CORRECTIVE ACTIONS**

- 35)** - Replace ice bin with an NSF approved ice storage bin with an integral cold plate so that liquid waste drain lines do not pass through storage bin.
  - Replace domestic Crockpot with NSF approved commercial unit when current Crockpot breaks.
- 36)** Provide a designated area for soiled wiping rags.
- 40)** Observed a few wiping rags hanging on equipment throughout facility. No container of sanitizer was available. Provide container of sanitizer for storing wiping rags between uses during hours of operation.
- 45)** Clean walls and floors in hard to reach areas throughout facility to remove accumulation of grease and dust.
- 52)** Generally clean and organize and remove all unused equipment/items from back storage area and food prep area (i.e. where slicer is used) so as to allow proper cleaning.
