OBSERVATIONS AND CORRECTIVE ACTIONS

31- Clean ice chute and nozzles of soda machine to remove some sticky residues and mold. –Provide tongs for all jerky displays. –Observed common jar of jalapenos stored on snack counter. Ensure jalapenos are properly stored/displayed for customer usage. Note: It is understood that nacho/chili machine will not be operable until deli remodel is complete, approved.

33- Clean inside of cabinets at beverage station to remove some residues and cobwebs.

43, 44, 45, 48- Observed 'remodel' of deli area in progress. Observed tile floor installed (no cove base tiles set) and hole/damaged wall area being repaired. Reported that restroom floor will be replaced and ice machine relocated to deli area. Submit plan check and applicable fees to this Department within next 7 days to continue remodel construction.
