OBSERVATIONS AND CORRECTIVE ACTIONS

- 7, 35-** Observed internal temperature of fried foods in hot case to range from 117-136°F, for short time period, when checked with inspector's thermometer. Observed burned-out heat bulb. Reported that temperature control for hot-holding case was accidentally turned down. Temperature adjusted during inspection. Monitor internal temperature of foods in hot case to ensure 135°F.
- 13-** Observed damaged canned foods (i.e. severely dented and springy can of pozole; swollen can of zucchini) stored on retail display shelves. Damaged cans voluntarily discarded during inspection. Ensure canned foods unsuitable for sale are not displayed on retail shelves. Observed some 'spoiled'/rotten vegetables (i.e. peppers, mushrooms) stored in retail display refrigerator.
- 32-** Observed improperly butcher-paper wrapped packages of sausage and sausage patties stored in display freezer. Reported that sausage is purchased from approved source and proportioned/repackaged. Provide complete labels for individual sausage packages.
- 34-** Observed various misc. food and non-food items stored in basins and atop drainboards of utensil sink.
- 35-** Clean electric slicer in hard-to-reach areas to remove some dried (tomato seed/vegetable) debris/residues.
- 41-** Repair drip at utensil sink faucet.
- 44-** Organize misc. food and non-food related items stored on floor behind front counter/at food prep area.
