OBSERVATIONS AND CORRECTIVE ACTIONS:

- 6, 21- Observed no hot water available at hand sink. Repair hand sink so as to have water of at least 100°F available.
- 13- Observed 2 bags of black-eyed peas to be infested with insects. Bags of beans voluntarily discarded during inspection.
- 35, 44, 45- Observed ice machine in operation located in unfinished area. Repair damaged wall behind ice machine and relocate machine so as to be on on self-coved sheet vinyl floor and under 'finished' ceiling area. Seal gaps at door/floor junction of back room. Note: Ensure a screen is on the end of ice machine drainpipe to prevent vermin/insect entry.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
