30- Observed bag of onions stored directly on floor of walk-in.

45- Clean floors in hard-to-reach areas to remove some food debris/residues and dust. Seal wooden supports for utensil sink to be smooth/non-absorbent.

**Note:** Reported that insert will be provided for storing beverage ice in bar's ice bin (so as to separate beverage ice from ice in contact with cooling plate).

Probe thermometer available and food cooking temperatures verified during inspection. Outdoor BBQ area reportedly not used.

Reinspection fees will be charged for all subsequent reinspection unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
