OBSERVATIONS AND CORRECTIVE ACTIONS: 6- No paper towels at utensil sink used as hand sink. Provide. No dedicated hand sink available in bar area. Provide. Observed hand sink faucets in restrooms to stay on for the following: Women's left side faucet 3 seconds, Women's right side faucet 5 seconds, Men's left side faucet 1 second, Men's right side faucet 6 seconds. Adjust all to provide minimum 10 seconds of warm, running water.

21- Observed hot water at utensil sink faucet at 112°F. Adjust/repair hot water heater to maintain minimum 120°F.

34- Replace existing two compartment sink with approved three compartment sink with dual integral drain boards within 6 months.

43- Observed strong urine smell in Men's restroom. Clean to eliminate odor.

Note: No foods being hot held during inspection.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
