**OBSERVATIONS AND CORRECTIVE ACTIONS:**

- 33-** Clean inside cabinet (at front) under paper bag storage/fry holder to remove food debris.
- 33, 35-** Clean countertop under "staging unit" to remove food debris/greasy residues. Repair/seal gaps at corners/edges of unit to facilitate cleaning. Reported repair scheduled.
- 35-** Clean underside of milkshake machine (by drive-thru) to remove some residues. Clean ice chute (for customer soda machine at left) to remove pinkish residue.
- 45-** Repair leak/damaged pipes for customer beverage machines and clean cabinet of pooled water/residues. Reported repair scheduled.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
