OBSERVATIONS AND CORRECTIVE ACTIONS: 11- Observed mashed potatoes at 94°F- 97°F in steam table. Food handler reports potatoes properly heated on stove then moved to steam table. Use available probe thermometer to ensure foods reheated for hot holding reach minimum 165°F before placing in steam table. Note: Potatoes returned to stove to be reheated to 165°F during inspection.

35- Observed food residues/rust on shelves in walk-in refrigerator and food residues/dust on shelves in kitchen area. Clean where needed.

36- Observed clean cooking jackets hanging in employee restroom. Relocate to prevent contamination. Note: Jackets moved to office during inspection.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
