9- Observed cooked rice 62°F on prep table, reportedly cooked previous operating evening and left at room temperature to cool overnight. Rice voluntarily discarded to trash during reinspection, see VC&D. All cooked potentially hazardous foods (PHFs) shall be properly cooled and PHFs shall be maintained at proper temperatures (41°F and below or 135°F and above); no PHFs are to be stored at room temperature.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
