OBSERVATIONS AND CORRECTIVE ACTIONS

- 30-** Observed bags on onions stored directly on floor.
- 35-** Observed a bit of dried food residue on base of slicer in hard-to-reach area. Observed food cans supporting shelf inside one-door upright freezer. Observed some plastic food tubs and colanders to be cracked.
- 38-** Properly install hood baffles so as to eliminate gaps.
- 41-** Observed walk-in condensate draining into bucket.
- 44-** Observed mop bucket filled with turbid water.
- 45-** Observed ceiling at cookline to be caving in and duct tape affixed between ceiling panels. Clean ceiling/walk-in cooler and floor/walk-in cooler junctions (on outsides of unit) to remove greasy blackish-colored residues. Observed gap between wall and top of coved base tiles in back storage area.
