7- Observed air temperatures in all cookline refrigerators at 36°F-39°F. Violation corrected.

9- No foods observed cooling in prep refrigerators. Reported all foods now cooled in walk-in refrigerator in shallow, uncovered containers. Violation corrected.

14- Food handler reports all cookline knives now properly cleaned in dishwasher. Violation corrected.
