OBSERVATIONS AND CORRECTIVE ACTIONS: 1- Food safety certificate expired October 2008. 6- No paper towels in restroom dispenser.

30- Clean insides and outsides of plastic bulk food bins to remove food debris/residues.

33- Observed worn/hard-to-clean wood shelving around utensil sink area.

35-Clean bottom shelf of glazing prep table to remove food debris/residues. Replace missing panel to compressor cabinet of counter display refrigerator.

36- Observed ice scoop stored atop cardboard box in freezer.

40- Observed wet wiping rags hanging from sides of utensil sink. Store rags in available and designated bucket.

44- Organize/remove misc. items not necessary to facility's operation. Organize cardboard delivery boxes and misc. items stored in back seating area.

45- Damaged/hard-to-clean floor shall be replaced with approved material within next 6-months. Clean floors along walls, corners and hard-to-reach areas throughout facility to remove accumulated dust and misc. debris. Repair damaged wall behind janitorial sink.
