OBSERVATIONS AND CORRECTIVE ACTIONS

- 35) Observed algal residues in beverage gun holder. Beverage gun holder was cleaned during inspection. Clean the bottom of all keg refrigerators to remove standing water and misc. residues. Clean inside ice machine to remove pink/white residues. Replace the beverage tubing and non-integral cold plate beverage cooling device in the ice storage bin with a cold plate that does not come into contact with the ice used for customer drinks within 6 months to a year.
- 36) Chain/secure all CO2 tanks to a rigid structure.
- 44) Reported that mop water is dumped outside. Cease this practice immediately and dump mop water in toilet.
