**OBSERVATIONS AND CORRECTIVE ACTIONS**

- 6) No paper towels/paper towel dispenser available at the bar hand sink- provide.
- 14) Reported that utensils are washed, sanitized and then rinsed in that order. The proper procedure for utensil washing is to wash, rinse, sanitize and then air dry utensils. Rinse and sanitize sink basins were switched during inspection. No test strips available for checking sanitizer levels at the utensil sink – provide.
- 35) Observed algal residues in beverage gun holder- clean. Clean the bottom of all keg refrigerators to remove standing water and misc. residues. Replace the damaged bottom panel in the keg refrigerator on the back wall. Clean inside ice machine to remove brown/white residues. Replace the beverage tubing and non-integral cold plate beverage cooling device in the ice storage bin with a cold plate that does not come into contact with the ice used for customer drinks within 6 months.
