OBSERVATIONS AND CORRECTIVE ACTIONS:

14- Observed food handler wipe in-use knife with soiled wiping rag sitting on prep refrigerator cutting board. Use utensil sink to properly wash/rinse/ sanitize all utensils when cleaning is necessary. Observed food debris on slicer not being actively used. Wash/rinse/sanitize slicer after each use or every four hours of continuous use.

21- Hot water at utensil sink faucet 114°F during inspection. Adjust water heater to maintain hot water at 120°F or above.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
