OBSERVATIONS AND CORRECTIVE ACTIONS

- 14- Food handler reports prep refrigerator cutting boards used to cut potentially hazardous foods are cleaned every night. Wash/rinse/sanitize after every four hours.
- 21- No hot water at front hand sink faucet. Food handler reports hot water takes 2-3 minutes to reach hand sink faucet. Provide minimum 100°F water at hand sink within 30 seconds. Hot water at utensil sink faucet reached 110°F—after approximately 3 minutes—during inspection. Adjust/repair hot water heater to maintain minimum 120°F hot water.
- 45- Replace missing ceiling panel over ice machine.
