OBSERVATIONS AND CORRECTIVE ACTIONS

- 14-** Observed a couple soiled wiping rags stored atop prep refrigerator cutting boards.
- 33-** Observed cardboard lining bottom shelf of range in prep kitchen. Observed some shelves above steam table lined with foil. Observed damaged areas of peeling/missing laminate countertops at sandwich prep and salad dispensing areas (especially around pan storage cut-outs for lettuce/dressings). Repair/replace countertops to facilitate cleaning.
- 33, 35, 41-** Observed damaged cabinet bottom under espresso machine. Observed liquid waste from espresso machine to be draining into bucket. Relocate machine so as to properly drain into an approved indirect sewage connection. Replace domestic refrigerator at espresso counter with approved commercial refrigerator within next 6 months.
- 45-** Continue to clean floors in hard-to-reach areas to remove food and misc. debris/residues. -Observed damaged ceiling of peeling paint adjacent to dishwashing area. -Repair damaged ceiling (as noted on 1-26-07 report) in condiment storage room and above walk-in freezer.
