OBSERVATIONS AND CORRECTIVE ACTIONS

7, 35- Walk-in cooler air temperature 50° F; babaganoush (46° F) at time of inspection. Walk-in cooler has reportedly been opened due to deliveries occurring today. Monitor walk-in cooler temperature and adjust if needed so as to maintain potentially hazardous foods at 41° F or less.

35- Replace broken bottom, front panel of storage freezer in back prep area. Paint chipped/ some rust on some shelves in walk-in cooler.

39- Replace broken thermometer in walk-in cooler. Replace dead battery of digital probe thermometer. Note: Dial-type (0°F- 220°F) probe thermometer available at time of inspection.

45- Resecure loose FRP panel to wall above back utensil sink.
