Whipped cream returned to refrigerator during inspection. Note: Reported cans whipped cream used within 1 hour. Time-Only may be used with whipped cream providing written procedure is posted and each can of whipped cream marked with discard time (4 hours after taking from refrigerator).
33- Observed a few worn/damaged area on cabinet laminate. Repair where needed to be smooth and easily cleanable.
35- Clean inside ice machine to remove residues.
