OBSERVATIONS AND CORRECTIVE ACTIONS: 5- Observed soap dispenser to be clogged of dried soap residue. Ensure hands are properly washed at handsink.

30- Observed some uncovered foods and foods stored in opened cans inside walk-in. Ensure foods are covered (when cool, marinating, stored) and cans are discarded once opened and food stored in approved food-grade containers.

36- Observed utensils stored in (yellow) container and container soiled with greasy food debris/residues. 41- Reported leaking walk-in condensate drain is under repair. **NOTE:** No live cockroaches were observed at time of reinspections. Continue abatement and clean floors/shelves of dead cockroaches.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
