OBSERVATIONS AND CORRECTIVE ACTIONS: 1- Observed available food safety certificate to be a copy. Original shall be kept on premises. Reported person named on certificate not employed by this facility. Provide documentation within sixty days that at least one person currently working at this facility has passed an approved food safety certification examination. Fax or mail to this Department. Please include name of facility on certificate.

14- Observed wiping rag damp with sanitizer sitting directly on top of stack of open nugget containers. Nugget containers discarded during inspection.

35- Observed black tape sealing cracks in walk-in refrigerator & walk-in freezer air curtains. Remove tape to facilitate cleaning. Clean behind and between nozzles of lobby beverage dispenser and ice chute and surrounding area of drive thru beverage dispenser to remove accumulated residues.

40- Observed soiled wiping rags on food contact surfaces throughout kitchen. Store wiping rags in container of approved sanitizer between uses.

41- Observed leak at utensil sink drain pipe. Repair. 44-Observed wet mop stored head down in closet. Store mop so as to dry completely between uses.

45- Clean floor sink under lobby beverage dispenser to remove residues. *Note: Dishwasher nonoperational; ensure all utensils cleaned in utensil sink.*

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
