14- Observed water in wash basin of utensil sink at 100°F. Maintain wash water at 110°F or above whenever wash basin is filled.

30- Observed nozzle at creamer cold holding unit to be cut straight across. Cut nozzles diagonally to prevent accumulation of cream held outside of refrigeration.

35- Observed pan catching leaking water under dishwasher. Repair.
