OBSERVATIONS AND CORRECTIVE ACTIONS

- 35- Observed ice for coffee drinks being stored in igloo type container at front counter. Provide NSF approved, insulated ice bin for coffee beverage ice. Note: Manger reports ice bin ordered. Clean area to right of ice chute at drive thru beverage dispenser, behind and between nozzles of lobby beverage dispenser and inside ice machine to remove residues. Clean inside refrigerator storing milk and dressings to remove black dust/food residues.
- 40- Observed a few wiping rags sitting on food contact surfaces throughout kitchen. Store wiping rags in container of approved sanitizer between uses.
- 45- Observed gaps at cove base tile/wall juncture behind utensil sink and missing cove base tile in walk-in refrigerator. Repair. Observed gaps in sealant at hand sink/wall and utensil sink/wall junctures. Re-seal.
