OBSERVATIONS AND CORRECTIVE ACTIONS

- 7, 35-** Observed raw steaks 48-50°F stored in refrigerated drawers at cookline. Replace torn drawer seals and repair drawers so as to easily open/close.
- 14-** Observed steak tenderizing utensil stored in food container filled with still water. Water discarded during inspection. Ensure tenderizer is cleaned and sanitized at least every 4 hours and stored in clean, dry container.
- 33-** Clean and repair damaged cabinet bottom storing beverage syrup boxes.
>Replace caulk around soda machine ice bin with approved food grade silicone, or similar easily cleanable, durable material.
- 34-** Replace damaged temperature gauge to dishwasher.
- 35-** Replace torn door seals to prep refrigerator at cookline and storage refrigerator in prep kitchen. Properly repair loose inner door panels to storage refrigerator.
- 36-** Observed tongs ice scoop stored directly atop ice bin. Store ice scoop in ice bucket or in ice with handle up.
>Secure CO2 tank to rigid structure.
- 45-** Continue to clean floors at cookline in hard-to-reach areas to remove accumulations of food debris and greasy residues.
