**OBSERVATIONS AND CORRECTIVE ACTIONS**

- 35) Clean the can opener on the prep table in back food prep area to remove food residues. Clean the door seals of the prep refrigerators and refrigerated drawers at the main cookline to remove accumulated food residues.
- 40) Observed some damp soiled wiping rags stored at cookline. Provide a labeled container of sanitizer solution (i.e. 1 ounce of bleach for every 4 gallons of water) for storage of wiping rags between uses.
- 44) Back door was open during inspection. Keep door closed to prevent entrance of vermin.
- 45) Re-grout tile floors (especially near dishwasher) where grout has been severely eroded. Remove the cardboard from floors at both cooklines.
