OBSERVATIONS AND CORRECTIVE ACTIONS: 6- No soap at hand sink in dough rolling area. Provide. Clean hand sink to remove food debris.
 7- Observed sliced ham (47°F), diced chicken (48°F) and sausage (46°F) in top of prep refrigerator (air temperature 39°F). Adjust air flow and keep lids closed between orders to maintain potentially hazardous foods at 41°F or below. Observed cartons of milk at 46°F-47°F in display refrigerator. Adjust/repair unit to maintain milk at 41°F or below. External thermometer indicates air temperature 38°F; 47°F with Inspector's thermometer. Replace thermometer or provide additional thermometer so as to accurately assess air temperature.
 36- Observed plastic cup used as scoop for garlic in top of prep refrigerator. Provide handled scoop.
 44- Observed gap under outside door (dough rolling area). Provide weather strip to prevent entrance of vermin.
 45- Observed a few broken cove base tiles in facility and FRP separating from walls at entry to dough rolling area. Repair where needed to be smooth and easily cleanable.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department.
