5) Observed food handler not change disposable gloves after touching face/doing other tasks and before serving food to customers (Note: handled utensils were used). Change gloves between tasks and as often as you would need to wash hands.

14) No sanitizer detected at dishwasher. Chlorine sanitizer bottle was changed during inspection, but still no sanitizer detected after many cycles. Adjust or repair dishwasher to maintain sanitizer level of 50 ppm at rinse cycle.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
