14, 20 - Observed ice scoop and cell phone stored on 'damp' wiping rag atop machine. Store scoop in sanitary manner (clean, dry container)

14, 18, 19 - Observed several cooking/serving utensils (spoons, ladels, bowls) ~~and~~ hot-holding unit and rotisserie oven stored in back room. Remove all cooking/serving equipment/utensils within next 5 days.

18 - Clean inside of ice machine to remove some mold. Clean bottom of slide-top beer cooler to remove pooled liquid. Observed pool of water on floor under beer cooler. Repair. Observed 3-door Top display refrigerator storing personal foods and bottled beer to be damaged (leaking rusty water onto floor) soiled with accumulated mold/algae residues on bottom and tracks. * Replace refrigerator with approved unit in next 30 days *

24 - Observed a few ~~used~~ damp wiping rags on bar.

29 - Remove duct tape on bar above 3-compartment sink and repair to facilitate cleaning

30 - Back door to garbage are opened. 31 - Clean floors under ice machine.


34 - No shatterproof light covers for "ice machine" back room.


