OBSERVATIONS AND CORRECTIVE ACTIONS:

- 33- Clean platform, below prep refrigerator of accumulated dust and misc. debris.
- 35- Clean inside, top of ice machine of some mold.
- 44- Clean up/ organize back storage room/ area—remove unused items so as to eliminate clutter and facilitate cleaning.
- 45- a) Refinish worn area of wall behind chest-type storage freezer in back room (recommend installing FRP panels on wall).
- b) Clean floor, in walk-in cooler, of residues. Replace broken floor tiles and regrout floor where grout has eroded out more than 1/8 inch in between floor tiles.
- c) Repair hole in ceiling and water damaged area of upper wall in back utensil washing area so as to be smooth, easily cleanable, non-absorbent and in good repair.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
