- 30-** Observed lid to cinnamon twist bulk container to be broken.
- 31, 35-** Observed some mold in drain traps of soda beverage machines (at drive-thru and customer counter). Clean under/between nozzle heads to remove some dusty/sticky residues.
- 36-** Observed cleaned food pans stacked together while still wet.
- 45-** Clean floors in corners/hard-to-reach areas to remove some dried food debris/residues.
