- 35- Clean bulk storage bins (reportedly unused) of dry ingredient debris/residues.
- 40- Observed wiping rags (dry) on prep table..
- 44- Organize/remove accumulated misc. personal-type items to facilitate cleaning.
- 45- Clean floors under shelving, (unused) refrigerator/freezers, bulk storage bins, in corners/along walls to remove food/misc. debris/residues.
