OBSERVATIONS AND CORRECTIVE ACTIONS: 7- Observed assorted deli meat (42°F-44°F) in top of prep refrigerator. Adjust/repair unit to maintain potentially hazardous foods at 41°F or below.

14- Food handler reports prep refrigerator cutting board used when slicing potentially hazardous foods is wiped with sanitizer through out the day and washed/rinsed/sanitized every night. Wash/rinse/sanitize after every four hours of use.

33- Clean cabinets and counters by prep refrigerator to remove accumulated residues.

35- Clean inside both refrigerators to remove accumulated food debris/residues.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
