OBSERVATIONS AND CORRECTIVE ACTIONS

- 6- No soap at women's restroom hand sink used by food handlers. Provide.
Note: Soap available at all other hand sinks in facility.
- 35- Observed crack in ice "bucket" sitting on ice machine. Replace so as to be easily cleanable. Clean inside ice machine to remove pink residues. Observed duct tape covering sawed off screws on doors to walk-in refrigerators. Remove tape and properly repair to facilitate cleaning.
- 38- No shatterproof light cover on light in walk-in refrigerator. Provide. Replace missing baffle on hood to properly filter air and prevent fire.
- 41- Observed pooled water around drain under dishwasher. Verify drain is functioning properly.
