35- Clean between cookline equipment and shelf below built-in countertop cooking inserts to remove some accumulations of food debris/greasy residues. >Clean 'Keen Kut Shoe Stringer' slicer to remove some dried food residues.

38- Provide shatterproof light bulb/cover for circular fluorescent bulb at bulk rice and bean storage area.

41- Replace missing (cold water) faucet handle at mop basin.

45- Continue to clean floors in hard-to-reach areas to remove food/misc. debris/residues. Observed many damaged/worn areas of floors throughout facility.
