OBSERVATIONS AND CORRECTIVE ACTIONS

1- No food safety certificate. Provide documentation within sixty days that at least one person currently working at this facility has passed an approved food safety certification examination. Fax or mail to this Department. Please include name of facility on certificate.

35- Observed some pink/tan residues in ice machine. Ice machine cleaned during inspection. Note: Shelving in walk-in refrigerator inadequate for proper cooling. Provide additional shelves.

39- Observed two-piece remote probe thermometer in kitchen. Reported remote thermometer used to check final internal cooking temperatures of potentially hazardous foods. Replace with easy to use digital probe thermometer.

45- Observed black residues on wall behind spray sink. Clean. Observed missing/damaged floor tiles through out kitchen. Repair.

Note: Kitchen manager reports entire floor scheduled for replacement. Flooring shall be approved, easily cleanable, covered at the floor-wall juncture with a 3/8 inch minimum radius and shall extend up the wall at least 4 inches.
