OBSERVATIONS AND CORRECTIVE ACTIONS: 9- No foods observed cooling during inspection. Kitchen manager reports all foods cooled in walk-in refrigerator at depths of 2 inches or less in uncovered containers and that all food handlers are now aware of proper cooling procedure. Violation corrected.
 14- Observed meat debris on slicer which was reportedly "clean". Provide small brush and flashlight to aid in the complete removal of potentially hazardous food debris from back area of blade. Food handler reports slicer cleaning procedure of wiping with sanitizer, washing with soapy water and rinsing. Proper slicer cleaning procedure is wash with hot, soapy water, rinse with clear water and sanitize with approved sanitizer.

Reinspection fees will be charged for all subsequent reinspection unless an acceptable corrective time schedule has been submitted and approved by this Department.
