- 33- Observed wooden shelving along backside of bar and inside cabinets to be dusty and worn. Reseal to facilitate cleaning. Observed bottom of cabinet (adjacent to cabinets under utensil sink) to be damaged and gap along bottom junction. Replace. Observed countertop to be worn at seams.
- 45- Clean floors throughout food area in hard-to-reach areas to remove accumulated dust and misc. debris.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
