OBSERVATIONS AND CORRECTIVE ACTIONS

- 33-** Repaint worn wood shelves storing beverage syrup boxes to facilitate cleaning. Repaint inside cabinets along utensil sink to facilitate cleaning. Observed bottom of cabinet (left of utensil sink) to be damaged. –Clean countertop under display refrigerator and microwave to remove dust and misc. debris. Observed some damage to countertop under display refrigerator.
- 35-** Clean bottom of keg refrigerator to remove some liquid/mold. –Clean under nozzle housings of beverage machine to remove sticky residues.
- 45-** Clean floor and wall behind/adjacent to keg refrigerator and ice machine to remove accumulated dust.
