OBSERVATIONS AND CORRECTIVE ACTIONS: All other violations noted on previous inspection/reinspection reports have been corrected at this time.

30- Replace broken lid to bin storing bags of dry ingredients. Relocate bin so as to not be stored under dishwasher drainboard.

33- Clean inside all cabinets at coffee bar to remove accumulations of food and misc. debris/residues.

35- Clean inside prep refrigerators and outside of microwave to remove food debris/residues. Replace missing/damaged handles to prep refrigerator doors.

38- No operable ventilation in restrooms.

40- Observed wet wiping rags under cutting boards at cookline. Provide non-absorbent, easily cleanable material to prevent cutting board slippage.

44- Generally organize/remove misc. items stored throughout and not necessary to facility's operations to facilitate cleaning.

45- Continue to clean ceilings and vents to remove dust. Observed many askew ceiling panels in back areas of facility.

>Continue to clean floors throughout facility in hard-to-reach areas, to remove food debris/residues and misc. trash.
